

# **Toddler care rates 2023**

## **Municipality Arnhem**

Toddler care aims to prevent and, where necessary, effectively combat educational disadvantages developmental delay among young children. We do this by working on the wellbeing and engagement of our children, with the help of schools and municipalities.

- ✓ Learning through play using methods for (early and) preschool education (VE)
- ✓ Methods aligned with collaborating primary school
- ✓ Focused on social skills, motor skills development, and language and numeracy development
- ✓ Available several half-days per week. 4 half-days per week, 2 half-days in consultation
- ✓ Extra focus on development as optimal preparation for primary school

The costs for toddler care depend on your personal situation and the subsidies, which vary from one municipality to another. Almost all municipalities distinguish between parents entitled to childcare allowance and parents not entitled to childcare allowance. The following page shows which situation applies to you.





## Calculate your costs.

### Are you entitled to childcare allowance?

It may be that you are eligible for childcare allowance; a government reimbursement of your costs. You can check whether you are entitled to any allowance on the <u>Tax Office's website</u>.

If you are entitled to childcare allowance, you will receive an income-dependent contribution from the Tax Office. Would you like to know exactly how much you will pay? Use our <u>calculation tool</u> for an easy personal calculation.

#### Are you not entitled to childcare allowance? Or do you have a 'Gelrepas'?

Are you not entitled to childcare allowance from the Tax Office? The municipality may contribute to the cost of toddler care. You will pay a parental contribution, where the amount depends on the joint gross income.

### Do you have an Early Years Statement (VE-indicatie)?

Has your child been given an Early Years Statement (VE-indicatie) by the health visitor? Then the municipality of Arnhem will pay for 7.5 hours of the 15 hours of toddler care.





If your toddler has a VE-indicatie, there are 2 options:

- You are entitled to childcare allowance. You get 7.5 hours for free from the municipality Arnhem. You can apply for childcare allowance for the other 7.5 hours.
- You are not entitled to childcare allowance. You get 7.5 free from the municipality Arnhem. For the other 7.5 hours you pay a contribution based on the joint assessment income. See the table below.

### **Expanation**

- The government rate for toddler care is € 9,12 per hour. This is the amount used to calculate the childcare allowance from the Tax Office.
- In 2023, no toddler care will be available in this municipality during week 1 (Christmas), week 8 (spring), week 17 (May), week 30, 31, 32, 33 (summer), week 42 (autumn) and week 52 (Christmas)
- We invoice the toddler care in 12 months.
