

Rates after-school childcare 2021.

As of 1 January 2021, Skar will apply the following rates 10 . These rates do not take into account the allowance you will receive from the Tax authorities. As a result, the amount you end up paying is lower than the monthly rate below. The Dutch national standard 1 for out-of-school childcare is $\leqslant 7.27$

Supplementary after-school childcare rates 2021.

- 1. The national standard is the standard amount used to calculate the childcare allowance of the Tax and Customs Administration.
- 2. With respect to the 12 school holiday weeks, we adopt the official holiday weeks as set by Rijksoverheid Regio Zuid. We also assume 2 weeks in the May holiday period.
- 3. The opening times of our out-of-school childcare centers (pre-school and after-school care) are the same as the school times and the entire school holiday weeks of the primary school.
- 4. For the 40-week plan, you will receive an invoice every month.
- 5. At some locations, we offer childcare starting from 7.00 hour. Our staff will bring the children to school. The number of hours per month can vary (this depends on the starting time of the primary school.
- 6. The plans and resources vary per location and is dependent on availability.
- 7. You can request extra childcare directly through the online parents' portal.
- 8. All arrangements are exempt from VAT.
- 9. For holiday childcare, only whole days can be used (from 7.30 to 18.30)
- 10. The monthly fee on your invoice may differ up to max. \in 0.10 in price compared to the gross monthly fee stated in the overview of rates.
